James River Streambank Restoration

Amherst County, Virginia

Sealed Bids for the James River Streambank Restoration project (the "Project") in Amherst County, VA will be received by Amherst County Service Authority (the "Owner") at 113 Phelps Road, Madison Heights, VA 24572 until **2:00 P.M.** local prevailing time on **Thursday, September 28, 2023**. Bids will be opened publicly at that time and read aloud. Results will be tabulated and provided to all bidders.

The work to be performed hereunder shall include the furnishing of all labor, materials, tools, transportation, supplies, equipment and appurtenances necessary for the complete and satisfactory replacement/rehabilitation of public utilities for the Amherst County Service Authority (the "Owner") as described in the plans. The work shall include, but is not limited to, approximately 410 LF of streambank stabilization of the James River. The work includes tree remove, bank restoration, and riprap stabilization as shown on the plans and as described in the technical specifications.

Prospective Bidders are urged to register with the designated website as a plan holder, even if Bidding Documents are obtained from a plan room or source other than the designated website in either electronic or paper format. The designated website will be updated periodically with addenda, lists of registered plan holders, reports, and other information relevant to submitting a Bid for the Project. All official notifications, addenda, and other Bidding Documents will be offered only through the designated website. Neither Owner nor Engineer will be responsible for Bidding Documents, including addenda, if any, obtained from sources other than the designated website.

Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including addenda, if any, obtained from sources other than the Issuing Office.

An optional pre-bid conference will be held at **10:00 A.M.**, local prevailing time, on **Thursday, September 7, 2023**. Meeting will be held at the Amherst County Service Authority office, 113 Phelps Road, Madison Heights, VA 24572.

This project is being funded with Federal and State money. Bidder must comply with the following:

- a. the President's Executive Order #11246 prohibiting discrimination in employment regarding race, color, creed, sex, or national origin;**
- b. the President's Executive Orders #12138 and 11625 regarding utilization of MBE/WBE firms; and the Civil Rights Act of 1964. MBE/WBE firms are encouraged to submit bids.**
- c. Bidders must provide certification that they do not or will not maintain or provide for their employees facilities that are segregated based on race, color, creed, or national origin.**
- d. Bidders must comply with the President's Executive Order 13658 regarding minimum wages on federal funded construction contracts.**
- e. Bidders must comply with Davis-Bacon Act requirements.**
- f. Bidders must comply with Section 436 of P.L. 113-76 American Iron and Steel Act.**
- g. Bidders must comply with Build America, Buy America (BABA) Act requirements.**
